The GPPRA Inc. committee states that there has been no remuneration paid and no benefits given to committee members, senior staff and their relatives.

Motions received.

1. Resident, Ross Paine (Villa 20) requested the following Motion be put forward for discussion and resolution.

Work Shirts for Bar Volunteers

"Approval of the purchase of 60 cotton polo shirts with a suitable logo, for use by bar volunteers when they are volunteering on behalf of the GemLife Pacific Paradise Residents Association Incorporated (GPPRA Inc). Total cost to be no more than \$2500. The shirts to be issued to all active volunteers and to be returned to the Bar Manager if/when the volunteer is no longer available."

Discussion included the following points:

- GemLife has not been asked to contribute as using the GemLife logo is very restrictive (Ross Paine Villa 20)
- All residents received a GemLife t-shirt which can be used (Glenda Larson Villa 31)
- Not all residents received a GemLife t-shirt (Jutta Jung Villa 81)
- The GemLife t-shirts are different colours for the 2 stages (Wendy Styles Villa 10)
- The GemLife t-shirts are synthetic and terrible to wear when working (Phil Tunstall Villa 108)
- We should support our bar staff by providing them with a t-shirt that is cool (Sue Story Villa 23)
- There are 45 people working in the bar (Ross Paine Villa 20)

Carried by show of hands.

2. Resident, Ian Stitt (Villa 14) requested the following Motion be put forward for discussion and resolution.

Quarterly Forums

"HOC to conduct open forums quarterly to answer requests submitted in writing from residents. These requests would take precedence over requests from attendees who attend. Forums would be limited to a specific time. This would give a better understanding of the workings of the HOC, compared to information received from

meeting minutes. This will give all residents a better feeling of belonging to this great community".

Discussion included the following points:

- The committee is not a corporate committee but one made up of home owners and volunteers. Open meetings could take a long time and not achieve outcomes. (Shane Storer Villa 114)
- Open meetings twice a year should be put to the new committee. (Wendy Styles Villa 10)

Not carried by show of hands.

3. Resident, Ross Sloane (Villa 123) requested the following Motion be put forward for discussion and resolution.

Funding Request for Setting Up the Lawn Bowls Program

"The GemLife Pacific Paradise Residents Association allocated a budget amount of \$2000 towards the establishment of lawn bowls at Pacific Paradise. This sport will not have equipment supplied, (unlike ten-pin bowling where shoes and bowls are supplied, or golf simulator, where golf clubs are supplied). Based on the number of 82 residents who have registered interest, it is likely about 60 residents are new bowlers and will not have any bowls. In addition, setting up will also need to budget for additional bowling aids, coaching aids, basic umpiring equipment. The equipment needs to be purchased in advance of the opening of the bowling green".

Discussion included the following points:

- Will the bowls be new or second hand? (Wendy Styles Villa 10)
- They won't be new bowls as \$2,000 won't go far (David Turk Villa 95)
- Experience from a previous community is that only 5 sets of bowls are required (Carol Walsh Villa 93)
- Questions include will they be taken off site, will they be locked up, can anyone use them? (Shane Storer Villa 114)
- Donated sets are good enough to practice with but there will be other requirements for umpiring etc. (Warren Williams Villa 147)

Carried by show of hands.

At this point the current Committee stood down and the Returning Officers (Joe & Dee Beath) advised the GPPRA members of the process for the election of HOC Office Bearers and Committee members from the nominations received.
